4. Your order will be processed as usual and the new cooktop dispatched within 5 days, pending payment if no account facility is available
5. Decommission and recycle your old Christie barbecue in line with local, state and federal disposal and recycling laws and directives.
6. The serial number of your decommissioned, recycled barbecue will be recorded by Christie, and no further support including advice or spare parts will be offered to the product.
